ORDER

In consideration of the Agreement for Consent Decree heretofore entered into by defendants Glenn Miller, in his capacity as Grand Dragon of the Confederate Knights, Knights of the Ku Klux Klan, heretofore known as the Carolina Knights of the Ku Klux Klan; the Confederate Knights, Knights of the Ku Klux Klan (CKKKK), and plaintiff Bobby L. Person individually and in his representative capacity as the named class representative, it is hereby ORDERED, ADJUDGED and DECREED:

1. This action is appropriate for certification as a class and the class, consisting of "all black citizens of the State of North Carolina who seek to exercise their state and federal rights free from interference by the defendants," has been certified and is represented by Bobby L. Person.

2. Plaintiff Person is ordered to notify absent class members of this settlement in conformity with Rule 23(e)

of the Federal Rules of Civil Procedure, according to a plan to be subsequently devised by the court.

3. This decree is binding upon the above named defendants, their agents, servants, employees, assigns, and successors.

4. The above named defendants are ordered not to operate a paramilitary organization and do other acts prohibited by North Carolina General Statutes 14-288.20(b)(1) & (b)(2) and 14-10.

5. The above named defendants are ordered not to do any acts in violation of North Carolina General Statute 14-12.12.

6. The above named defendants are ordered not to march in any predominantly black neighborhood in the State of North Carolina.

7. The above named defendants are ordered not to harass, intimidate, threaten or harm any black person, or white person who associates with black persons, who is exercising or attempting to exercise any right or privilege under the laws of North Carolina or the United States Government.

8. Plaintiff Person's claims for damages against the CKKKK is dismissed.


9. This decree settles all claims between the above named parties, including all pending motions and requests for discovery.

10. The above named parties each shall bear their own costs and attorneys' fees in this litigation.

11. The terms of this order shall have full force

and effect until such time as the court reviews any objections which class members may have to the proposed settlement. After allowing class members an opportunity to file whatever objections they may have to the proposed settlement, the court may issue an amended order reflecting such changes as may be deemed necessary.
